THE ADOPTING PERSON(S) AGREES(S) AS FOLLOWS:

- 1. I will keep this cat as a house pet and not permit it to run free outside of the house. I will take every care to prevent this cat from getting outside accidentally. If this cat escapes and is not recovered within 24 hours, I will notify Beyond Nine Cat Rescue, Inc. immediately.**
- 2. I will give this cat the care and attention needed to insure its health and well-being. I will provide proper supervision if small children will be handling the cat.**
- 3. I will provide this cat with adequate fresh water and food, shelter, exercise and regular veterinary care, including vaccinations.**
- 4. I agree to abide by Beyond Nine Cat Rescue's policy of not declawing this cat.**
- 5. I will confine this cat to a pet carrier whenever being transported outside the home.**
- 6. I will keep this cat for the remainder of its life, and will not turn it over to any other person or persons without the prior approval of Beyond Nine Cat Rescue, Inc.**
- 7. If, for any reason during my guardianship of this cat, I cannot comply with the terms of this adoption agreement, or if the adoption is not satisfactory, I will contact Beyond Nine Cat Rescue, Inc. immediately. I will not take this cat to any shelter for disposal or turn it loose outside to fend for itself, nor will I barter, sell or give it to another, nor allow it to be used for medical or any other experimentation. One of Beyond Nine Cat Rescue's remedies will be to recover this cat from me on demand and I agree to surrender the cat to them immediately.**
- 8. I will love and keep this cat as an important member of my family.**

I understand that Beyond Nine Cat Rescue, Inc., makes every possible effort to insure a compatible adoption, and gives thorough care to the evaluation of physical condition and temperament of each cat and kitten. I will not make any claim against Beyond Nine Cat Rescue, Inc., its officers or agents, with respect to this cat or any injury which it may cause. I hereby release Beyond Nine Cat Rescue, Inc., its officers or agents, from any liability related to the adoption of this cat.
